<p>We only use your personal information for legitimate business needs in respect of your relationship with ourselves and no other purpose.</p> <p>Where applicable, we will use the personal data provided for contacting you, invoicing you, making grants, processing payments, employing you etc.</p> <p><b>Letting us know data has changed or is wrong, you want to withdraw consent or you want us to stop using your data</b></p> <p>Please contact us to update, withdraw consent, seek information about what we hold or remove your personal data. We will only remove your data if there are no legal reasons why we cannot do so.</p>	<p>We promise:</p> <ul style="list-style-type: none"> <li>- To keep your data safe and private.</li> <li>- Not to sell your data.</li> <li>- To give you ways to manage and review your choices regarding the data held at any time.</li> </ul>	<p><b>Data we collect when you use our services</b> includes the amount, frequency, type, location, origin and recipients:</p> <ul style="list-style-type: none"> <li>- Personal details i.e. Name and address, telephone numbers and email addresses.</li> <li>- Councillors' personal other significant interests and pecuniary interests.</li> <li>- Payment and transaction data. Profile and usage data. This includes the profile you create to identify yourself when you submit information through our website contact page.</li> <li>- We collect information when computers and mobile phones, using cookies access or view our website.</li> </ul> <p><b>Data from third parties we work with:</b></p> <ul style="list-style-type: none"> <li>- Local authority agencies</li> </ul>	<p>We may share your personal information with these organisations:</p> <ul style="list-style-type: none"> <li>- HM Revenue &amp; Customs, regulators and other authorities</li> <li>- Bodies we have a joint venture or agreement to co-operate with</li> <li>- Organisations/companies you ask us to share your data with.</li> <li>- If you are employed by us and information is required by HMRC and other government bodies as part of payroll or pension requirements</li> </ul>

<p>After you cease links with us we have to keep some data for longer than 10 years if we cannot delete it for legal, regulatory or technical reasons.
